**MINUTES:** A motion was made by Byron Benoit to accept the June minutes as stated in the Newsletter. Second by Barbara Lucas. Passed.

**TREASURER'S REPORT:** A motion was made by Rose-Marie Stevens to accept the June 2001 Treasurer's Report. Second by Al Simmenroth. Passed.

### COMMITTEE REPORTS:

#### *Fund Raising Reports:*

1. Fundraising Report: Rose-Marie Stevens announced that we received a check from Albertson's for \$50.32; a check from Kroger will be sent next month for \$3.56.
2. Bass Pro Shop fundraising opportunity will be available to all members from August 4 to August 12. Saturday shifts are 11:30 am to 5:30 pm and 5:00 pm to 10:00 pm; Sunday shift is 12:30 pm to 6:00 pm; Thursday & Friday shifts are 4:30 pm to 10:00 pm. Sign up sheets were passed around. Work involves bagging merchandise, hanging or folding merchandise, etc.
3. Sharon Finnegan announced that the Bake Sale is scheduled for October 27 at Kroger. Baked items need to be at Kroger's around 8:00 a.m. Sharon will need some help, so anyone volunteering would be greatly appreciated. Call Sharon for more details.

1. Chris Shanahan reported that we have 73 paid members.

#### *Newsletter Report:*

1. Chris Shanahan – Apologized for not getting the newsletters mailed; he had computer problems.

### EXECUTIVE UPDATES:

1. Leah Benoit mentioned that we had received an invitation to the Hurst PD meeting on August 16. The meeting held at the Brookside Convention Center at 7:30 p.m.. The topic is Murder Crime Scene.
2. Leah also mentioned that as of July 15 we had sold \$23,515 in bricks. Anything that we make now, minus the cost of the bricks and labor, will be the Association's.
3. By-Laws: Before voting on the By-Laws, Ed Benyon asked that we keep Article 7.01 as it is currently written in the old By-Laws. Article 7.01 refers to only needing one signature on a check under \$250. Anything over \$250 will require two signatures. Linda Martin made a motion to accept the new By-Laws with the one change to Article 7.01. Second by Helen Wagner. Passed.
4. Leah Benoit showed a brochure regarding a 911 Cell Phone Program. The program is designed to help people that need phones to call 911 in an emergency situation. Old cell phones are programmed for 911 operation only. Lt. Mike Brown will check into the program further. If we decide to do the program, a brochure can be handed out at the Bake Sale for more exposure.
5. C.O.P.: Don Martin announced that Barney Snitz was the winner of the Name the COP column in the newsletter. The name will remain the same. Barney received a gift certificate. Don was looking for people to sign up on August 3, however, with the Symposium taking place that weekend, the car may have to just sit in the parking lot. Don said that they had a lot of fun doing the City of Bedford July 4<sup>th</sup> Parade. He hopes that we can do it again.
6. Chief Carmack informed the members that Eules has reviewed it's policies regarding the incidents that took place in Arlington and McKinney and found that these incidents should not happen as long as policy is followed properly. Training is in place. Chief Carmack also gave an update on the new Police Department. Projected move is still on track for October 12. The new facility will be computer software driven. Access keypads will allow people to be in only the areas assigned to
