



Spotlight on Sue Kosec

Sue was born in Erie, Pennsylvania, but grew up in Girard, about 15 miles east of Erie. When she was five years old, she moved with her parents to a remodeled chicken coop on her grandparents' farm. Her father gutted it, removed the feathers, added dry wall and linoleum and called it home. She wrote that there were "two rooms (sort of)," a bedroom she shared with her parents until her sister was born and a "great room." Among



other things, the "great room" contained a couch, a kerosene heater, and the bed she used after her sister was born. It also shared space with the kitchen area where Sue's mother heated the water they used for their weekly baths. The outhouse was 100 yards away.

When she was nine, her father added a living room and an indoor bathroom to the chicken coop. By the time she was 12, however, the family had moved to Wickliffe, a suburb of Cleveland, Ohio. This is the town she calls "home." Sue married Cliff in 1993. They lived in several places during their married life including Painesville, Ohio, Louisville, Kentucky, Akron, Ohio, Roswell, New Mexico, and Euless, Texas. Actually, their current Euless residency is the second time they moved to Euless, a community that obviously appealed to them.

They are the parents of two children, a daughter Alescia and a son Donald. Her daughter and son-in-law are both Navy retirees who chose to move from San Diego to Euless; Sue loves having them live a half mile away. Alescia is a 911 Dispatcher in Grapevine, and her husband Mark works for AT&T. Their son Donald and his wife Dawn live in Willowick, Ohio, with their two children. They haven't been persuaded to move to Euless yet. Sue wrote that Donald played in several softball leagues and has coached numerous little league teams. Donald may have gotten his love of athletics from Cliff who is an avid runner and has competed in many marathons and 50K trail races since 1975, that's a 31-mile trek. He ran the Pikes Peak Marathon three times, in 1982, 1983 and in August 2009.

Our Tony Burnett told Sue about ECPAAA when she visited the police station to talk about a homicide in her neighborhood. She was graduated from the last single CPA class on March 28, 2008. She then went on to take CERT classes and was graduated May 24, 2008. Since the bug had bitten her, she went on to attend the last single CFA class and was graduated October 30, 2008. She joined both the CPA and CFA alumni associations and is also a participant in the CART program. She wrote that she joined because it "seemed to be the next leg in the journey." She learned in her classes that there were many opportunities for service, and serving is what she wanted to do. Service gives her a great sense of accomplishment.

When asked what she would like the ECPAAA membership to know about her, she wrote that she had two fears—flying and those animals that slither across the ground whose identification starts with "s." She also described the circumstances that brought her in contact with John F. Kennedy during his campaign for the presidency, Tony Orlando and Dawn, race car drivers Emerson Fittipaldi, Arie Luyendyk, Mario Andretti and Michael Andretti. She also had several opportunities to talk with the late Byron Nelson.

As many of you know, Sue's favorite hobby is paper crafting. With the help and encouragement of a close friend, she has sold her cards to shops in Roswell, Grapevine and Colleyville and to five hospice houses, one of which is in Fort Worth. Of the 4000 cards she has created, no two were alike. She wrote that she liked to use old photographers of ancestors whose photos have been stored in albums and boxes for years. She likes to embellish and display them for all to enjoy. She wrote that she was privileged to have taken a class with Donna Downey and to attend several workshops conducted by Tim Holtz two prominent individuals in the field of paper crafting.

In 2008, Scott became certified as a Drug Recognition Expert Instructor, and remains active in the DRE program. Scott holds a Master of Science Degree in Criminal Justice, and teaches criminal justice courses periodically throughout the year.

When he is not at work, Scott enjoys working on his home, and spending time with his beautiful wife of 11 years, and his precious 6 year-old daughter. Scott attends Gateway Church in Southlake, and he is an avid fan of Trinity Football, Ole Miss, and the Manning brothers (Peyton and Eli).
