

The meeting was called to order by Rose-Marie Stevens at 7:04 p.m. Rose-Marie gave the Invocation and led the Pledge of Allegiance. Mark Merrick led the Texas Pledge of Allegiance.

Teresa Alexander read a letter of appreciation from the Euless Court. During Warrant Roundup, over 1000 warrants were collected in full or in part, yielding over \$100,000 in fines; it is possible that up to \$313,000 will be collected.

Tim Stinneford made the motion to approve the minutes for April 2006, and Betty Overstreet seconded the motion. It was passed.

Treasurer's Report. It was acknowledged that the report published in the last newsletter was not the most current. Teresia Foreman passed out copies of the current treasurer's report and advised that we would begin showing information from meeting to meeting. This new format was recommended by the CPA firm that audited our books. Due to the length of time taken to complete the audit, we were given a discount by the firm.



Teresia reported that she needed to make correction to the report regarding the amount allocated for Police Appreciation week. Jackie Benner advised that it was also necessary to verify the amount spent for Police Appreciation week. The committee had been authorized to spend up to \$500.00. In the meantime, J. R. Goad had negotiated the receipt of a Wal-Mart gift card for \$150.00 and a donation of \$300.00 from Mike Bowman Real Estate. Any excess monies may go to the Police Appreciation Banquet. Tim Stinneford made a motion that we accept the Treasurer's report; David Mishkin seconded the motion, and the treasurer's report was approved.

Police Appreciation. A huge thank you to the Hospitality Committee was expressed. The bags of goodies given to the police officers were a bit hit. The brown bags held 16 items, incl uding notepads, candy, other snacks, coins with a police logo, etc.

By-Laws. The by-laws committee was available to discuss changes as presented in the copy mailed to everyone. The discussion revolved around the inconsistency in capitalization and the need to improve the grammar and punctuation. There was also discussion about the suggested methods for voting for officers. One method allows for voting by mail and the other method advocates voting in person only. The by-laws committee will review the document and make the recommended grammatical corrections before again making it available for membership review.

It was noted we had a Class 1 visitor, Sara Chandler, who changed her status from visitor to member.
