Strengthening Euless CERT Disaster Medical Operations Exercise

As we continue to build our CERT skill set through independent learning, please re-read **Unit Three**, **Disaster Medical Operations** -- **PART ONE**. Then, please spend 20 minutes thinking through the following CERT Challenge.



It is noon on a Sunday. Two church vans collide on 183 Westbound above Ector. Each van is carrying 30 passengers. Four other cars are also involved in the wreck. EPD needs help and activates CERT.

When you arrive at the scene, the incident commander assigns you to work the Emergency Medical Operations tent. The victims have already been triaged, and you are assigned three patients tagged "Immediate."

Your first patient is a 35-year-old male who is not breathing. You shake him and speak to him but he does not respond. You suspect he has an obstructed airway.

What do you do?

How do you open his airway?

How do you safely maintain his open airway?

Your second patient is a pregnant woman with a large bleeding wound on her right forearm just below her elbow. She is screaming.

What do you do first? Do you have bandages splints in your CERT bag?

Where do you apply direct pressure?

Is the pressure light or firm?

How do you maintain the pressure?



Should you tie the pressure bandage with a bow or a knot? Why?

Do you elevate her arm? If so, how high?

Which pressure point will work best? Brachial or femoral?

Your third patient is an elderly man. He has rapid and shallow breathing, cannot follow commands and has a capillary refill of 4 seconds. He is in shock.

What do you do first?

After you lay him on his back, how high do you elevate his feet?

How can you maintain his body temperature if you do not have a blanket available? What could you use?

He asks for water. You have a bottle of Ozarka in your backpack. Can you give him a drink?
