May Speaker

Lisa Fondren

President, Fondren Forensics Inc.

Technical Supervisor for the Breath Alcohol Testing Program

Lisa Fondren is a forensic chemist who provides technical oversight for the breath alcohol program in parts of Dallas, Collin, Denton and Ellis Counties. She maintains and calibrates the breath alcohol equipment, trains the officers and detention personnel on the equipment and provides expert testimony in DWI trials. The following two paragraphs describes what Lisa will be presenting at our meeting on May 17th.

Alcohol is a drug (depressant) that affects a person's ability to safely operate a motor vehicle. Police Officers spend a large amount of time on DWI related arrests. Many people are multiple offenders and are arrested and convicted of DWI more than once. We will take a closer look at what is involved once an individual is arrested for DWI and is offered a breath alcohol test. Instrument maintenance and operator knowledge are important components of a successful DWI process. Defense attorneys routinely attack the accuracy of the instrument, the credibility of the officer and the integrity of the technical supervisor.

Determining a person's alcohol concentration at the time of driving is a routine part of a Technical Supervisor's testimony. This calculation is based on the results of the breath test and other information obtained at the side of the road or the interview. The science behind the instrument and the physiology of alcohol in the body are important aspects that are discussed in the courtroom.


