## November Speaker

### Mark Lowery

#### Special Agent in Charge , Customs and Border Protection

Back by popular demand, Mark will share some of his past experiences over the last 34 years. He presently serves as the Special Agent in Charge for the U.S. Customs and Border Protection Office of Internal Affairs. In this capacity he oversees various internal corruption and administrative investigations involving Customs and Border Protection employees and oversees IA offices in El Paso, Del Rio and Dallas, Texas. His area of responsibility covers North Texas, New Mexico, Oklahoma, Nebraska, Missouri and Kansas.

Mark previously served with distinction in various capacities with the U.S. Secret Service for twenty-three years and began his career with the Secret Service in St. Louis, Missouri in 1983. Subsequent career assignments have included Washington D.C., Atlanta, Georgia and Dallas, Texas.

During his career, he conducted numerous protective security advances for the President of the United States. From 1987-1991, he was assigned to the Presidential Protective Division during the Reagan and Bush presidencies. During this time, he traveled extensively to foreign countries in support of the Secret Service's protective mission. Additionally, he held major assignments for the 1990 G8 Economic Summit in Houston, Texas and the 1996 Olympic Games in Atlanta, Georgia.

As the Special Agent in Charge, Mark was responsible for the oversight of Secret Service protective activities and criminal investigations in the Secret Service offices in Dallas, Lubbock, Tyler and Waco, Texas. Protective responsibilities included oversight of security for the President's Crawford Ranch, personal protection responsibilities for all visits by the President into the Dallas District and the numerous foreign dignitary visits to the Crawford Ranch and elsewhere in the North Texas region. Criminal investigative responsibilities included matters relating to a broad range of financial institution fraud, credit and debit card fraud, cyber crimes and the counterfeiting of U.S. Currency.

Mark received numerous performance recognition awards throughout his Secret Service career. In 1985, he was awarded the U.S. Secret Service Valor Award, the agency's highest award, for his courageous actions circumventing an armed robbery. Mark retired from the Secret Service in October 2006.

Mark is a graduate of Virden Community High School in Illinois and Illinois State University. Prior to his employment with the Secret Service, he was employed as a police officer with the St. Louis County Police Department in St. Louis, Missouri.

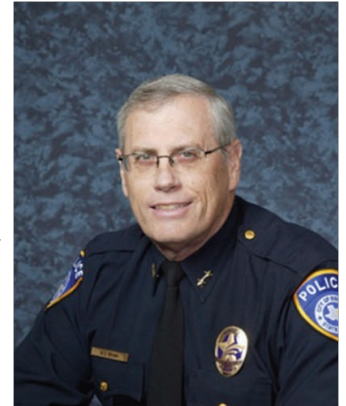
Mark is a Christian and a member of the Stonebriar Community Church.

## **FROM THE CHIEF**

On Saturday, October the 22<sup>nd</sup>, I had the opportunity to attend the Guns and Hoses boxing tournament that was held in Mesquite. I have heard of this event in the past, but never attended. I know the money raised in the event goes to the fallen Police Officer's and Fire Fighter's families, and I know the absolute need these families have for financial and moral support. I went this year because our own Ramon Fraticelli was competing and I wanted to support him.

Once I got to the event, I realized just how special this night was going to be. The Mesquite Rodeo Arena had been transformed into a boxing venue, complete with a boxing ring, all kinds of flashing lights, pretty ring girls and a ring announcer that would make you believe you were watching a world championship event.



I was all ready to enjoy the evening of boxing when I got a text message from my long time friend, Bruce Southey. Bruce and I started our law enforcement careers at about the same time with the Richland Hills Police Department back in 1974. We both started out as Police Cadets and both promoted to Police Officer over the next year. Bruce and I have kept in contact over the years and it's always a good time when we get together. Bruce was at the Guns and Hoses event, saw that a Euless officer was on the fight card and was certain that I would be there to support our officer. I met up with my old friend, who is about to retire from Fort Worth PD, and we were catching up on what was going on in our lives. He knew why I was at the event, but I asked him what brought him from Fort Worth all the way over to Mesquite. He said he was there with Hank Nava's family. Hank was Bruce's partner back in 2005 when Hank was killed in the line of duty. Bruce then pointed to the table where he was sitting and I could see the Nava family and a few other Fort Worth PD officers there with them. He then pointed to a large row of banners that were hanging from the ceiling that held the names of the Police Officers and Fire Fighters who have lost their lives in the service of their communities. He pointed with pride and a sense of tremendous loss to Hank's banner.

That's when the full weight of the evening set in on me. It was going to be a great evening of fun, we had brought a large contingent of Euless fans to the event, but it was also going to be a very special night for the families of the fallen Police Officers and Fire Fighters. Before the boxing started they took the time to introduce the families of the fallen Officers and Fire Fighters. Each family member was introduced, and I watched them proudly stand and be recognized. I couldn't help but think how badly they wish they were not the ones being introduced, how they wish they could share just one more evening with their loved one. It was heartwarming to see the respect and appreciation that was shown these families. It reinforced to me the absolute need to do all we can to protect those who protect us.

I enjoyed the boxing and the fellowship I shared with the people around me, but I can't help but wish that we never have to honor another fallen Police Officer or Fire Fighter. That somehow, someday each Police Officer and Fire Fighter can go home every day at the end of their shift and we never need to raise money for those family members who are left behind. Until that day comes, I ask that we all remember those who have given their all, and that we have a special place in our hearts for those valiant families who have to find a way to pick up the pieces and travel on.

The night ended with Ramon representing the Euless Police Department very well. I could not be more proud of him, and I thank him for the sacrifices he made to compete in this event.

I will leave you with one of my favorite quotes. I believe it speaks to us all, and it's a personal message to Ramon.

*It is not the critic who counts; not the man who points out how the strong man stumbles, or where the doer of deeds could have done better. The credit belongs to the man who is actually in the arena, whose face is marred by dust and sweat and blood; who strives valiantly; who errs, and comes up short again and again, because there is no effort without error or shortcomings; who knows the great enthusiasms; who spends himself in a worthy cause; who at the best knows in the end the triumph of high achievement, and who at the worst, if he fails, at least fails while daring greatly, so that his place shall never be with those cold and timid souls who know neither victory nor defeat.*

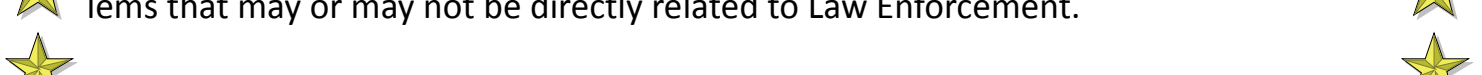
My wife Misty (former Miss Texas Contestant) and I have been married 12 years and have three children, Madison (11), Isaac (8) and Britton (2).



★ **What are your hobbies?** I enjoy spending time with my family and working out using Cross-fit and collecting firearms of all shapes and sizes, and an avid shooter.



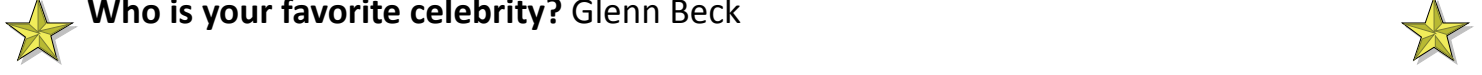

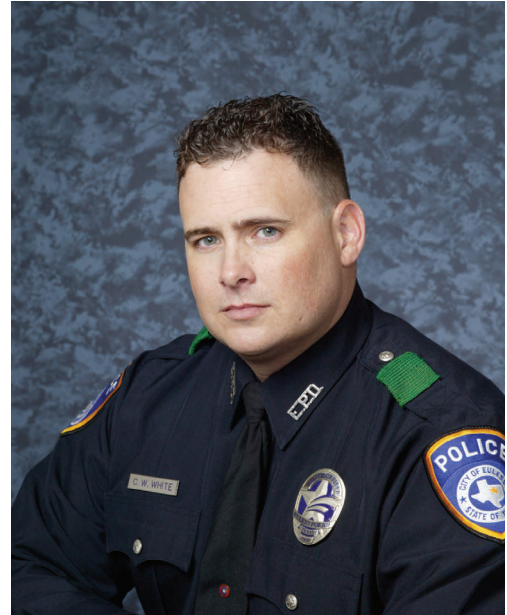
