

The year is coming to a close very fast. It seems like just yesterday we were all concerned about what the "new millennium" would bring. We have that behind us but as we approach another holiday season we have the same problems and concerns we always have, this time a year is a time when burglaries and thefts typi-

cally increase. This is brought about because of our increased shopping trips and the fact that many of us store gifts in our homes for Christmas. Let me encourage each of you to be aware of what you do. Watch for who is around whether in your neighborhood, or the parking lot of the shopping mall. While shopping store items in your trunk, not your back seat. We have done some crime analysis and have found that in over 50 o/o of all car burglaries the vehicles were unlocked and in a great number

of those valuables such as cell phones, lap top computers, and purses were left in plain view. Lets take a minute and make sure our homes are locked when we leave, our cars are locked when we park them even if it is at home, and either lock our valuables in the trunk out of sight, or take them with us.
