Hi everyone! I want to say welcome to the members of the 16th Citizens Police Academy class. Please feel free to stop by any week during their 12-week course to meet and say hi to these folks.

At the August meeting, the members voted to purchase a Crime Prevention Robot for \$5,075 and two treadmills for the workout room for \$10,450. The robot and treadmills

have been ordered. The robot will take around 2-3 weeks to build and it will have its own EPD uniform and the treadmills should already be in place by the time you receive this newsletter. We are excited about these purchases and hope the department will enjoy them for many years. We, along with the Police Department, will be holding a contest to name our little robot friends (there will be two heads, one male and one female, that can be interchanged on the robot). A committee has been formed to figure out all of the logistics for the event when our friends make their appearance in public. More details will be given at the October meeting.

3. Leah Benoit mentioned that we need a 9-11 Day Committee. Ruth Zavala, Erelene Hill and Wes Weeks volunteered. They will get with Kathy Haecker for some direction.
4. Barney Snitz, Bob Bouse and Faye Stinneford volunteered for the Nominating Committee to select the slate of officers for 2003.
5. Leah Benoit mentioned that the "Wish List" money had been discussed with Chief Carmack, Sara Munday, Susan Vest and herself. The Department is wanting a robot for the NPO's to use with the schools. A brochure was passed around for members to view. The total cost of the robot will be \$5,075.00 and will be customized with an EPD uniform. The other request was two Precor treadmills for the workout room. Total cost for the treadmills will be \$10,450.00. The equipment is top of the line and a plaque will be added to the treadmills acknowledging the ECPAAA for purchasing them. After the presentation of each request, Leah stated that we needed to spend the money since we did not spend any money on the Department last year. A list of the where the money would come from was passed out. The Post Office Box and computer hardware/softer/printer were budgeted items that the Executive Board agreed would not be needed/purchased. The other money came from the 2001 carryover, Arbor Daze, Heroes Baseball event and Miscellaneous Donations. Total money available for the purchase of the Wish List items is \$15,698.00. Several questions were asked and answered regarding other ways to spend the money and maintenance on the equipment. Bob Bouse made a motion to purchase the robot and both treadmills since the research had been done and the Chief wanted the items. Second by Tim Stinneford. Passed. Sgt. Pavlik said that he would look into getting the Association a computer from the City for our office. He also said that he would be responsible for the treadmill maintenance. A committee has been formed with members and the NPO's to decide how the robot will be announced to the public.
6. Don mentioned that everything is going well. He also mentioned that the September 3 meeting will be very important for trained COP's to attend.
7. Kathy Haecker made a motion that we allow the President, Vice President and Treasurer the ability to go on-line to check the status of our bank accounts and do any banking on-line that is necessary. Second by Tim Stinneford. Passed.

COMMENTS FROM THE FLOOR:

A motion was made by Tim Stinneford to adjourn the meeting at 8:43 p.m. Second by Bob Bouse. Passed.
