



**TEXAS CITIZENS POLICE ACADEMY ALUMNI ASSOCIATION**  
**SUMMARY OF THE 2010 STATE CONVENTION &**  
**LAW ENFORCEMENT TRAINING**

Leah Benoit and I were able to go to the convention in Bryan/College Station August 11-13, 2010, and, in my opinion, it was one of the best. Following is a summary of some of the sessions I attended.

**Drug Endangered Child Team Program**

Sergeant James Woodward talked about the program that has been established in Brazos County. They follow the guidelines developed by the Texas Alliance of Drug Endangered Children. TADEC was established "in an effort to protect Texas children living in volatile drug environments. Professionals from law enforcement, child protective services, the criminal justice system, medical and mental health professions, educators, and other child advocates have come together to make children a priority." Sergeant Woodward indicated that 802,000 children in Texas live in homes where parents use drugs; this includes alcohol. Children who live in environments where methamphetamine and other drugs are produced face an even greater danger because of the volatility of the manufacturing process. **Sex Offender Registration**

There are 716,750 registered sex offenders in the United States. The top five states are California, 120,762; Texas, 60,994; Florida, 54,166; New York, 30,436 and Washington, 20,419. Rhode Island is the state with the lowest number of registered sex offenders, 1,565.

The state sends postcards to area residents when high-risk offenders move into the neighborhood; however, we were told that the risk descriptions were determined by psychologists. Police officers tend to view the risks differently.

**Amber Alert Program**

This was a very interesting topic because we learned the criteria recommended by the Federal Government for determining when an alert should be issued. Each community has to take into consideration the resources it has. For example, Brazos County initially based its program on the one established here in the Mid-Cities; however, they had to make some modifications. For example, here we have radio and TV stations that operate 24/7; in Brazos County, they shut down at midnight or earlier. They may be able to listen to a radio program in the middle of the night, but it was prerecorded. Consequently, they handle alerts differently during off hours.

Following is a summary of the criteria for issuing an Amber Alert recommended by the Department of Justice:

There is a reasonable belief by law enforcement that an abduction has occurred.

The law enforcement agency believes that the child is in imminent danger of serious bodily injury or death.

There is enough descriptive information about the victim and the abduction for law enforcement to issue an Amber Alert.

The abduction is of a child aged 17 years or younger.

The child's name and other critical data elements, including the Child Abduction flags, have been entered into the National Critical Information Center (NCIC).

**SUMMARY OF THE 2010 STATE CONVENTION & LAW ENFORCEMENT TRAINING — Continued from Page 5****Animal Control – Link Between Animal Cruelty and Family Violence**

Learning about this link was very enlightening. The speakers, Ashley Wesp and Patty Stepp, approached this topic from an historical point of view. We learned that it has been socially unacceptable to treat animals cruelly since 1641. In 1751, William Hogarth was so dismayed by the routine acts of animal cruelty he saw in London that he created four printed engravings showing the four different stages of cruelty. His fictional character, Tom Nero, is first shown as a young boy torturing a dog; the next engraving shows Nero as a young man torturing a horse; the next engraving, the third stage of cruelty, shows that Nero has succumbed to robbery, seduction and murder; and the fourth engraving, the fourth stage of cruelty, shows that Nero has been hung for murder and his body mutilated by surgeons in an anatomical theatre.

They also told us about Mary Ellen Wilson whose sufferings as a child led to the establishment of the New York Society for the Prevention of Cruelty to Children in 1874. Mary Ellen endured severe abuse at the hands of those who were meant to protect her after the death of her parents. Mrs. Wheeler, an humanitarian, learned about Mary Ellen from people she assisted who lived near Mary Ellen and told her about the child. When New York agencies would not assist, she approached Henry Bergh, president of the American Society for the Prevention of Cruelty to Animals (ASPAC). They were able to get Mary Ellen out of her horrible situation.

Although, Henry Bergh acted as a private citizen, the American Humane Association was formed when the New York SPCC and several Societies for the Prevention of Cruelty to Animals merged in 1877.

**Drugs, Alcohol, Your Teen and You**

The speaker's primary message was that our children learn from us. He described many of the creative ways our youth, preteens and teens, acquire and consume alcohol. Did you know it is possible to consume alcohol without getting it on your breath? Do you know about the eyeballing method for getting drunk? Do you know how to smoke alcohol? If you don't know the answers to these questions, you will have to wait until our next meeting to find out. I've already used up too much space.
