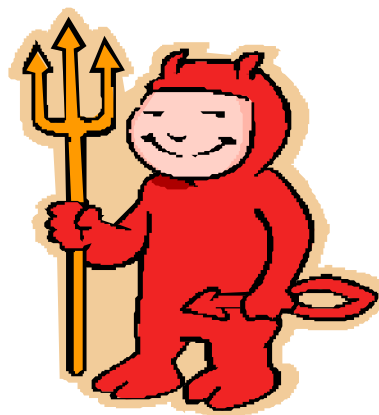

Complies with policies and procedures set forth by the By-Laws of this organization.

First Vice President - (1) In the absence of the President or the ability or refusal to act, shall perform the duties of the President, (2) performs duties that may be assigned by the President or the executive board, (3) maintains weekly communications, or as needed, with the President, (4) coordinates and secures the monthly meeting site and prepares for meetings, (5) attend all executive board meetings. Out of all help groups only 1 out of 99 succeed. THIQ is a chemical in brain that activates cravings. David Mishkin reported he used to smoke 6 – 10 packs a day and has not smoked since age 37. Great going David. There was some discussion on drugs and the legality of such. Unfortunately drugs cause the takers many problems and the rest of us pay with the higher cost of health care.

Treasurers Report. Current report passed out prior to start of meeting. This month received income of \$341.52. Expenses of \$2566.79. Checking balance of \$7887.97. It was noted there had been a discrepancy of a deposit made last December of \$682.05. The details have been located and matches deposit. J. R. closed out our money market account held at Southwest Bank which was held after we changed banks. An amount of \$1061.98 has been deposited into our current checking account. Kathy had an excellent slide presentation which highlighted many areas of the subject. Many different situations can affect first responders. We need staff that are educated and can act when situations occur before it affects someone we care about. The Program provides support to recruit, hire and train and equip. Communication and Awareness are very important. Our Police Department is in the process of training several members in this area. Kathy urged us to be aware of any books we might see in garage sales and bring them in to have on hand for our officers to read. Kathy also hand several handouts with information on Crimes Victims Assistance.

Liaison - Sgt. Gary gave out forms to be filled out and returned for those who were FEMA trained to work with Evacuees. COP's have a new radio. Possible future project COP's would be to contact Business's and update their emergency information. More details to follow on this project. CERT - Those in the CERT class have had their pictures taken with the new improved ID camera. At the October meeting new ID's will be taken for those who do not have one of the new ones. If your ID is lost a letter to Sgt. Gary is required. Another project that COP's



may receive is putting out speed stations in different locations in Eules. Once details are worked out we will be advised. It was reported that Junk Vehicles that have been reported have 45 days to appear and show they took care of the problem. We do not need to follow-up. COP shirts for the newest graduation class have not come in yet. Effective January 1st Tony Burnett will join CID. Sgt. Gary advised he will be our liaison for at least another 1 1/2 years.
